Re: Request for Extension of time to file and serve Objections in Hearing on California Waterfix Water Rights Change Petition

Dear Hearing Chair Doduc and Hearing Officer Marcus:

Protestant Islands, Inc. respectfully requests a 27-day extension of time in the Hearing on the Waterfix Change Petition for the filing and service of written objections concerning the petitioners' case in chief. This request, if granted, would change the current time for receipt of written procedural/evidentiary objections from 12:00 noon on June 15, 2016, to 12:00 noon on July 12, 2016.

Petitioners' May 31 submittal includes proposed testimony, witness qualifications, exhibit lists, and more than 180 exhibits, which require close study and analysis. Petitioners also recently submitted updated modeling related to the proposed project, which includes at least 19.3 GB of data, according to the Water Board's website. It is not reasonable or realistic to expect that protestant will have read and evaluated the voluminous set of documents and modeling analysis submitted by petitioners by June 15.

Islands, Inc. joins in extension requests submitted by other protestants including the Central and South Delta Water Agencies, AquaAlliance, Sierra Club California, Friends of the River, California Sportfishing Protection Alliance, Environmental Justice Coalition for Water, Environmental Water Caucus, Planning and Conservation League, Restore the Delta, County of San Joaquin, San Joaquin County Flood Control and Water Conservation District.

Granting this extension request will provide protestants reasonable opportunity identify and present appropriate objections to petitioners' May 31 submission and updated modeling analysis in advance of the July 26, 2016 hearing commencement date, while ensuring that petitioners are apprised of the objections in sufficient time prior to the hearing.


