**☐ Leak Detection (3 SWRCB Contact Hours) – October 15, 2020 @ 7 am**

- 4 ways to Reduce Leakage, the art of Leak Detection, Reactive or Proactive Leakage Management, review of preliminary survey, zones and zone measurements, pinpointing leaks, and estimating leaks.
- PowerPoint demonstration and discussion of leak detection, modern methods of leak detection, acoustic leak detection, and correlation equipment.
- Water loss identification and prevention and accountability
- Making Estimates – Rates of water loss for a roughly circular hole can be estimated

- The Impact of California Droughts
- A review of statewide and regional water conditions.
- Water Conservation and Drought Planning
- Small Water Systems and Tribes - Resources to Combat Challenges

**☐ Regulatory Updates (3 SWRCB Contact Hours) – November 5, 2020 @ 7 am**

- Background of Regulatory Setting
- Covers updates and existing regulations and how they apply to you water system
- Reviews operator certification, system classification, basic SDWA requirements, disinfection, Total Coliform Rule Requirements, and Source Water Protection

**☐ Well Diagnostics, Rehab, and Maintenance (4 SWRCB Contact Hours) – November 19, 2020 @ 10 am**

- Discussion of the various tools and techniques available to diagnose and treat various well problems ranging from bacterial contamination to reduced well yields, well sanding, and well casing issues.
- Discussion of well rehabilitation and maintenance techniques
- The goal is to optimize operational efficiency and reduce operating, as well as increase the operational life span of the well to reduce overall capital costs to the water purveyor.

**☐ Water Conservation/Water Shortage Management Plans (4 SWRCB Contact Hours) – December 10, 2020 @ 8 am**

- This course will cover the different types of forms of water conservation planning with information based on your water system needs and capabilities, Water conservation stages, Creating a conservation plan
- This course will also review the tools and public education materials available to systems implementing a conservation plan, Simple Steps to Save Water and Money
- This class will also cover potential financial issues with revenue that can occur when not considered in the planning and implementation of a water shortage/conservation plan, where does my water come from
