# **Notice of Water Right Application A033142**

Triangle T Water District has filed an application to appropriate water by permit with the State Water Resources Control Board (State Water Board), Division of Water Rights. The project associated with the application is located in Madera County and would divert water from the San Joaquin River stream system.

# **Summary of Water Right Application A033142**

Date of Filing: The application was filed with the State Water Board on July 22, 2020.

**Source of Water:** The source of water are the Chowchilla and Eastside Bypasses, which are tributaries to the San Joaquin River thence the Pacific Ocean.

**Amount:** The maximum amount of water requested for diversion is 74,350 acre-feet per year, which would be diverted at a rate not to exceed 750 cubic feet per second.

Season of Diversion: The season for diversion of water is from January 1 to May 31.

Protests must be received by the Division of Water Rights by **4:30 p.m.** on July 5, 2021, with copy provided to the applicant.
